MODERN & IMPRESSIONIST AUCTIONS NEW YORK, NOVEMBRER 2015



Sotheby's Impressionist & Modern Art Day Sale on November 6th, 2015 featured a broad array of pictures, works on paper and sculpture by the leading artists of the late nineteenth and early twentieth centuries. Highlights included an oil portrait of a bather by Paul Cézanne which was once owned by Paul Signac, a 1906 Fauve picture by Raoul Dufy from a distinguished Asian collection, a monumental port scene by André Lhote from a private collection in Scandinavia, and an extremely rare and widely published oil by Heinrich Campendonk from the collection of Jules and Gladys Reiner. The sale included an exceptional selection of surrealist art from private collections, including several major paintings and sculptures by Max Ernst and what is arguably the most important work by Dorothea Tanning ever to appear at auction. Furthermore, Sotheby's Evening Sale on November 5th included a work from Picasso's Blue period: *La Gommeuse*, which sold at \$67,450,000. A total of \$306,712,500 was sold for only 47 artworks during this sale. Kazimir Malevich's great Suprematist paintings, and Van Gogh's landscapes stood out from a great selection of internationally recognized artists with the likes of Magritte, Bonnard, Léger and Pissarro.

Christie's \$146-Million Impressionist and Modern Evening art sale quietly closed the fall auction season. Pablo Picasso's Analytical Cubist still life *La carafe—Bouteille et verre* came in as the night's top lot, selling for \$10.5 million, slightly over its \$9-million presale high estimate. This sale did set one auction record with Jean Hélion's *Abstraction*, at \$3.4 million, for the 1935 painting, which soared past its presale high estimate of \$800,000. Coming in second for the evening was a Paul Cézanne still life of apples, *Pommes sur un Linge*, that was once briefly stolen from the Art Institute of Chicago and held hostage, according to the auction catalogue, before being returned safely. Christie's Impressionist and Modern Day art sale was led by Pablo *Picasso's La Carafe* for a total of \$10,469,000.
